Nevis is a 36-square miles jewel, lies near the top of the Lesser Antilles archipelago. Given the alias, 'Queen of the Caribbees' in 1671, the island is accepted for its small, sombrero shape like statue. HISTORICAL EVENTS

- **1493:** Sighted and named by Christopher Columbus on his second voyage.
- **1834:** Emancipation. (Abolition Act 1833 end slavery in the British Empire on 1st August).
- **1861:** First Nevis postage stamp issued.
- **1899:** The hospital was destroyed in a hurricane. It was located on Old Hospital Road.
- **1906:** The Queen's House, once residence of the Governor was transformed into the hospital and named Alexandra Hospital after Queen Alexandra.
- **1950:** The First Secondary School, (Charlestown Secondary) was opened.
- **1956:** The Federal Colony of the Leeward Islands was dissolved and St. Kitts, Nevis and Anguilla became a separate colony.
- Newcastle Airport opened.
- **1958:** The colony of St. Kitts, Nevis and Anguilla entered the West Indies Federation as a single unit.
- **1959:** M.V. Christena began its ferry service between Nevis and St. Kitts. It was 160 ft. in length and owned and operated by the Government.
- **1961:** Nevisians, led by Eugene Walwyn, sought secession from St. Kitts.
- **1967:** St. Kitts and Nevis attained Associated Statehood with Britain.
- The new Constitution changed the status of St. Kitts-Nevis-Anguilla from Colony to Associated Statehood; however, the rebellion of Anguilla kept her from being part of the new State.
- The new Constitution provided for the Nevis Local Council.
- **1970:** M. V. Christena sank off Nag's Head, St. Kitts while on its journey to Nevis. Approximately 240 passengers most of whom were Nevisians, perished.
- A group of Nevisians formed the Nevis Reformation Party (NRP) with Simeon Daniel, a Lawyer by profession as the first President.
- The Nevis Island Administration Building was constructed.
- **1974:** The Nevis Dramatic and Cultural Society founded CULTURAMA, a festival dedicated to preserving the culture-music, dance, crafts and cuisine of Nevis.
- **1979:** Introduction to Caribbean Examination Council (CXC) proficiency examinations for secondary students.
- **1980:** The MV Caribe Queen went into service replacing the MV Liamuiga which was wrecked in St. Kitts by tropical storm David in August 1979.
- February 19: Following the General Elections, the Nevis Reformation Party formed a coalition with the People's Action Movement. Simeon Daniel was given the portfolio as Minister of Finance.

- **1983:** St. Kitts and Nevis attained political independence from Great Britain on September 19.
- Princess Margaret unveiled the dedication plaque as part of the Independence Celebration.
- Alexander Hamilton House was renovated to house the Nevis Island Assembly.
- Mr. Simeon Daniel became the first Premier in Nevis.
- Mr. Spencer Byron was named the first President of the Nevis Island Assembly following the attainment of Independence.
- The Nevis Island Administration built the Sixth Form College next to Charlestown Secondary (CSS).
- Mr. Herman Liburd became Speaker of the National Assembly.
- Mr. Weston Parris was appointed the first Deputy Governor General for Nevis.
- **1984:** The Education Department changed the primary schools in Charlestown from segregated boys and girls schools to a co-educational platform.
- **1985:** Queen Elizabeth II unveiled a plaque at the Power Station in Prospect.
- SKANTEL replaced Cable and Wireless as the telecommunication provider.
- **1987:** First post-independence (Local Island Assembly) elections held in December.
- **1988:** The Nevis Water Department laid new lines in Nevis, the service was metered and from this time consumers began paying for water.
- The Voice of Nevis (Radio VON) went on the air, becoming the first privately owned radio station in the Federation.
- **1989:** In the Federal Elections voters returned the PAM/NRP coalition to office for a third straight term.
- **1990:** First vote in Parliament for the Secession bid for Nevis. Needed 4/5 but other members of the NRP did not support Hon. Simeon Daniel.
- **1991:** The first 5-Star Hotel – Four Seasons Resort was opened with John Stauss as General Manager and Isadore Sharpe as President of the Four Season brand.
- **1992:** Local elections held on June 1. First change of Government in the Local Assembly. The Concerned Citizens Movement (CCM) led by Vance Amory won 3 of the 5 seats, replacing the Nevis Reformation Party (NRP) led Nevis Island Administration. Hon. Simeon Daniel was leader of the party.
- June 5: Weston Parris, the Deputy Governor General died in office.
- **1994:** His Royal Highness, the Duke of Edinburgh visited the island.
- The first local born to be ordained Priest of the St. Paul's Anglican Church, Ernest Flemming.
- **1995:** SKANTEL provided the first internet service on Nevis to Hanver Trust Company.
- Hurricane Luis and Marilyn came back to back and caused severe damages.
- His Honour, Eustace John was sworn in as the 2nd Deputy Governor General of Nevis.
- **1996:** The Nevis Island Administration dedicated Phase One of the Waterfront renovation project on September 19th.
- **1997:** In June the Nevis Island Assembly led by the Concerned Citizens Movement held the first reading of the Secession Ordinance, which called for a vote for separation from St. Kitts.

- On September 19th the Newcastle Airport was renamed Vance W. Amory International Airport.
- **2003:** The Nevis Island Administration renovated and upgraded the Alexandra Hospital.
- **2004:** The newly built Combermere Primary School was officially opened and renamed the Violet O Jeffers-Nicholls Primary School on September 2nd.
- Charlestown Post Office was officially reopened after months of renovation.
- **2005:** The Prospect Primary School was renamed the Ivor Walters Primary School on 22nd September.
- October, saw the appointment of the First Resident Judge for Nevis, Her Ladyship, Justice Ianthea Leigertwood-Octave.

The Hon Vance Amory (then Premier of Nevis) and Political leader of the Concerned Citizens Movement, passed the baton and leadership to the Hon Mark Brantley (then Deputy Premier of Nevis).
- December 18th, Nevis Island Local Election was held. The Concerned Citizens Movement won 4 of the 5 seats.
- December 19th, the Hon Mark A.G. Brantley was sworn into office as the 3rd Premier for the island of Nevis.
- **2018:** March 18th, the Official Opening of the Nevis Athletic Stadium (Mundo Track). The sporting facility, a 9-lane 400 meter track is the first of its product in the Caribbean and third in the world, following China and Brazil.
- August 31st, Her Honour, Mrs. Hyleta Liburd was sworn in as the new Deputy Governor-General, replacing Mrs. Marjorie Morton who acted as Deputy Governor General during the period September 2017 to August 31, 2018.

- October 21st, E Robelto Hector was elected as the 3rd Leader of the Nevis Reformation Party (NRP), one of the political parties in Nevis.
- October 25th, The Custom Courier service which is housed in Daniel's Deck building on the corner of Government Road and the Island Main Road, was renamed as the Brian A David Customs Courier Facility.
- 2019: March 21st, The Prince of Wales and the Duchess of Cornwall made a courtesy call to Nevis.
- April 12th, Mr. Herman W. Liburd Esq. J.P former Speaker of the National Assembly died.
- April 28th, The Courthouse was renamed after Theodore L. Hobson Q.C; Nevis longest serving Attorney.
- November 28th, the newly constructed Multipurpose Centre at Market Shop Gingerland, was named after David Freeman; The David Freeman Centre of Excellence.
- 2020: March 5th, Mrs. Cleone Stapleton-Simmonds of the Nevis Reformation Party (NRP) candidate won the Nevis 5 by-election.
- March 28th, The Prime Minister Mr. Timothy Harris announced a state of emergency to protect the citizens from the spread of Covid-19 worldwide pandemic.
- June 5th, general elections were held and the ruling coalition Team Unity consisting of PAM, CCM & PLP won with nine out of eleven directly elected deputies.
- October 31st, the borders reopened to all international flights.

Structure of the Nevis Island Administration

Modeled off the West-Minister System with a Constitution as the Supreme Law, the Federation of St. Christopher and Nevis has a democratically elected government with a unicameral structure of parliament. The uniqueness of the 1983 Constitution Order of St. Christopher and Nevis, gives credence for autonomy for the island of Nevis.

With five (5) single-member constituencies and a majority rule voting system for a period of five years term of assembly, the constitution allows for a composition of the Nevis Island Assembly. As such, there are eight (8) parliamentary members who are elected and/or nominated to serve.

As a constitutional monarchy within the Commonwealth of Nations, the Federation recognizes Queen Elizabeth 11 (British Monarch) or her successor as the titular head of government. The Monarch is represented on the island of Nevis by a Deputy Governor General appointed by the Governor General (titular head) of the Federation, who is constitutionally responsible for the government of both islands.

Since the realization of Independence in 1983, the island of Nevis is governed by an administrative division known as the Nevis Island Administration.





CHART DISPLAYING THE COMPOSITION OF THE NEVIS ISLAND ASSEMBLY AS AT DECEMBER 31, 2020



The Nevis Island Assembly has the authority to pass and or amend certain ordinances. When in session, the assembly is controlled by the President, who is presently, His Hon Mr. Farrell Smithen. He once held the position of Clerk of the Assembly from 1997 to 2003.

The Deputy Governor General is responsible for delivering the throne speech at the first sitting of the assembly following an election process. Presently, Her Honour, Mrs. Hyleta Liburd is the Deputy Governor General. She was sworn into office on August 31st, 2018. She continues to hold the position as at the end of 2020.

The Ministers of the Nevis Island Administration and their portfolios are listed in the below tables; and also the member of the Opposition who was elected and is the representative for that constituency.

Since obtaining independence as a Federation, the island of Nevis has participated in 16 elections by the end of December 2020. These elections comprised of 8 Federal Elections and 8 Local Elections. The charts below exhibit the two political parties, the Concerned Citizen Movement (CCM) and the Nevis Reformation Party (NRP) that contested these elections.





VOTES CAST IN NATIONAL ASSEMBLY (FEDERATION) ELECTIONS 1995 - 2020



POPULATION

This section of the digest deals with information pertaining to the population on Nevis, tallied during each census between 1871 and 2011. It also pertains to births, deaths and infant mortality rate for the past five years. Likewise, data on marriages and divorces are part of this section.

The population throughout the last censuses has seen general declines and increases as the population continues to change with migration and immigration. Births and deaths also contribute to changes in the population and assist in calculating the median population between censuses.

Marriages and divorces also impact a country's population either through immigration or migration or the addition of children to the marriage.

The number of deaths and births are closely linked to changes in the population in any given year. Changes to the distribution of a county's age groups have economic and social impact as the size of the population in any country determines the demand for goods and services



HEALTH

There are many health issues affecting the Nevisian Public. These range from hypertension, diabetes, kidney disease, HIV/AIDS etc. There are data given for the prevalence of these diseases here on Nevis along with injuries recorded for patients seeking medical attention at the Alexandra Hospital.

Chronic and communicable diseases are devastating to individuals and community, threatening quality of life. The Pan American Health Organization (PAHO) noted that “the Caribbean has the highest death rates from heart disease and the top five countries for diabetes in the Americas” Among the countries in the Caribbean Community (CARICOM), heart disease ranks as the leading cause of death. Other conditions such as cancer, stroke, diabetes, and HIV are among the leading causes of death.

With this in mind the Ministry of Health through its Health Promotion Unit provides vital data on the prevalence of diabetes, hypertension and HIV/AIDS in the Nevisian community as well as ways to reduce the risk of illnesses, diseases and injuries and encourages the general public on ways to live healthy productive lives.





Under this section information is given on the number of households tallied during censuses on Nevis; number of building permits issued; titles issued and deeds registered. Information is also presented on the electricity production and consumption as well as water consumption.

A household is a group of persons who make common provision of food, shelter and other essentials for living. Small average household sizes, of three persons were found to be the average household on Nevis in the last census of 2011.

The number of households is calculated during a census and is updated with assistance from the Physical Planning Department and the Property Valuation Department of Inland Revenue Department. Over the past five (5) censuses the number of households on Nevis has been steadily growing. The characteristics of households, including their size and composition contributes to sustainable development, poverty and assists with patterns of consumption which helps to shape the human impact on the environment.

Building Permits are issued by the Physical Planning Department within the Ministry of Communication. Building Permit is a person's formal permission to begin the construction, demolition, addition or renovation on their property. These permits can be commercial as well as residential. It is the duty of the Physical Planning Department to make sure building are built to the existing codes.

Titles and deeds for properties can be found at the Registry of the Supreme Court House in Charlestown. A Property Title is a bundle of rights in a piece of property in which a party may own either a legal interest or equitable interest. The rights in the bundle may be separated and held by different parties. It may also refer to a formal document, such as a deed, that serves as evidence of ownership. A Property Deed is a written and signed legal instrument that is used to transfer ownership of real property from the old owner (the grantor) to the new owner (the grantee).

Electricity and Water production and consumption are directly linked to the size of households within an economy. The number of persons within a household directly affects the consumption of electricity and water production on a monthly and yearly basis. Water and electricity are also consumed by commercial properties, thus the growth in this sector will affect both production and consumption.






Transportation

This section looks at registration of vehicles, number of licensed vehicles, number of written and road test, recorded traffic accidents, air and sea movements, cargo movements and trade.

A vehicle registration plate, also known as a number plate or a license plate is metal or plastic plate attached to a motor vehicle for official identification purposes. All countries require registration plates for road vehicles such as cars, trucks, and motorcycles. Here on Nevis vehicles licenses are done according to the month that corresponds to the last digit of the license plate. It is a legal requirement in Nevis for **ALL** types of motor vehicle to be registered if they are to be used on the public road. All new and imported vehicles are required to be registered and this is administered by the Traffic Department of the Police Force in conjunction with The Inland Revenue Department.

A potential driver is given a written test, to test the knowledge of how to operator a vehicle on the public road and to test the potential driver's knowledge of road use and signs. Once this test has been passed the potential driver is then taken on a road test to prove their skills in maneuvering the vehicle and adhering to traffic signs.

During any given year there are a number of traffic accidents that occurs. This information is captured by the Traffic Department within the Police Force showing the various types of traffic accidents that occurred.

The movement of passengers and cargo by aircraft has become the primary means of common carrier traveling. This provides greater efficiency and value are obtained when long distances are traveled, high-value payloads are moved and immediate needs are met. Air transportation is a significant industry in the Nevisian economy. Air transportation is subjected to domestic and international policies due to the importance of trade, diplomacy and national development.

Sea Transportation refers to movement of goods and passengers on waterways by using various means like boats, steamers, launches and ships. The movement of person, goods and services between the twin island Federation of St. Kitts and Nevis, the region and internationally continues to impact economic growth.

Tourism is the most vital industry in the Nevisian economy. In this section data is provided on accommodation, visitor's arrivals, stay over and length of stay. Information is also given on yachts and cruise calls to our shores.

Accommodation on Nevis tends to either be up in the cools of the hills with a spectacular view of the surrounding or near the coast for ease of a quick or leisurely dip in the cool blue waters. On Nevis there are choices of accommodations ranging from luxury hotels, colonial style inns, superb villas, contemporary condos, privately owned homes, bread and breakfast inns, seclude inns or the cool home of friends and family. All accommodations offers comfort and relaxation and a time for real rejuvenation.

Tourists come to Nevis for various reasons such as vacation, business, medical, sports or visiting friends and family etc. and stays for different length of time. The arrivals at the Vance Amory International Airport varies each year sometimes with an upward trend and sometimes with a downward trend.

Yacht and Cruise Tourism plays a major role in our Tourism Sector. Over the years cruise calls are plentiful during the period of November to April in overlapping years the remainder of the year normally see a decline in cruise arrivals. Yacht tourism is one of the most developing niche tourism sectors around the world. Yachts tourism is not seasonal and there are days when there are a number of yachts anchor in or waters or just a few.







Social Services

Nevis has grappled with some level of poverty in society and related problems for decades and thus anti-poverty strategies and social programmes had to be implemented. These social programs and assistances are designed to reduce poverty for the vulnerability groups and promotes sound economic decisions to assist in reducing welfare dependence. Social Assistance can be in either cash or in-kind, and are transferred to vulnerable individuals or households with no other means of adequate support, including single parents, the homeless, or the physically or mentally challenged.

These programmes includes but are not limited to hot meals program, food vouchers, baby sitter assistance, elderly day care, bus passes for the elderly, assistance to victims of domestic abuse, reduction in water and electricity bills for the elderly and child protection.

Finance

Covered under this section are Nevis Island Administration (NIA) Revenue and Expenditure. Revenue data is available from Inland Revenue Department, Customs Department and Financial Services. Also Gross Domestic Product (GDP) by constant and current and Gross Domestic Product by Economic Activity.

Revenue can be defined as the total amount of money generated by a company's operations for a certain period of time while expenditure is payment of cash or cash-equivalent for goods or services, or a charge against available funds in settlement of an obligation as evidenced by an invoice, receipt, voucher, or other such document.

The revenues of the NIA is collected mainly from taxes, fines, charges, licenses, levies and duties. The Inland Revenue, Customs and Financial Services Departments are the three most important revenue collectors. The financial position is calculated by subtracting Expenditure from Revenue. A surplus is derived when revenue is more than expenditure and a deficit is derived when revenue is less than expenditure.

The Gross Domestic Product (GDP) is the total value of everything produced by all the people and companies in the country.

Education

In this section data is given on Pre-schools and Nurseries, Primary Education, Secondary Education, Tertiary Education and Adult and Continuing Education.

Education is defined as the process of facilitating learning, or the acquisition of knowledge, skills, values, beliefs, and habits.

A preschool, also known as nursery school, pre-primary school, playschool or kindergarten, is an educational establishment or learning space offering early childhood education to children before they begin compulsory education at primary school.

Primary Education also called elementary education is for children in kindergarten through sixth grade. Primary Education provides students with a basic understanding in the areas of English, Mathematics, Science, Social Studies and Computer. Primary education provides students with fundamental skills that will be the foundation for the rest of their academic career.

Secondary schools may be called high schools refers to the last five years of statutory formal education (forms one to five). During Secondary Schools students are required to complete the following subject areas of Mathematics, English and History while having a choice in the other subject areas.

Tertiary Education refers to any type of education perused beyond the high/secondary school levels. Tertiary Education offers certification at a higher level which includes diplomas, undergraduate and graduate certificates, an associate, a bachelors, a master's and doctoral degrees. In Nevis Tertiary Education is offered by the Nevis Six Form College and the University of the West Indies Distance Education Centre. Adult and Continuing Learning includes person who are above school age wishing to gain passes in subject areas offered by the Caribbean Examination Council (CXC). Adult learning options includes online degrees completion, professional advancement and personal enrichment courses.



Employment

Covered under this heading is data on employment which includes the working age population by Sex and Parish, Unemployment and Unemployment Rate by Sex and Parish, Average Employment by Selected Industries, Work Permit Application by Sectors, and Work Permit Application by Nationality.

Labour, but particularly income and employment indicators are critical in analyzing economic and social progress at both the macro and the micro levels. Without these, no meaningful assessment of development performance is complete. Therefore, it is critical for each country to have timely information on labour and income aspects of the development process.

Labour force comprises of people ages 15 and older who supply labor for the production of goods and services during a specified period. It includes both the employed and the unemployed. In general the labor force includes the unemployed, and first-time job-seekers, but excludes homemakers and other unpaid caregivers and workers in the informal sector.

Over the years the Labour Force has changed with an aging population and the influx of other nationalities. With the introduction of Free Movement under the Revised Treaty of Chaguaramas provides for the free movement of non-wage earners, either as service providers and/or to establish businesses, including managerial, supervisory and technical staff, and their spouses and immediate family members. This has led to an increase in the Labour Force on Nevis.




Trade

Trade involves the commercial transaction involving the sale and purchase of good, service or information. In its simplest form trade is the exchange of one thing for another within borders or across borders and is vital to the success of civilization. Trade involves but is not limited to goods, clothing, electronics, building materials and cars.

A country's exports are goods and services that it produces and sold to other countries. A country's imports are goods and services that is brought from other countries. All countries export and import goods and services, and all countries benefit from it. By exporting, a country gains income. By importing, it can obtain products that it does not have within its borders.

Exports and imports are important for the development and growth of national economies because not all countries have the resources and skills required to produce certain goods and services. Nevertheless, countries impose trade barriers, such as tariffs and import quotas, in order to protect their domestic industries.

An import in the receiving country is an export from the sending country. Importation and exportation are the defining financial transactions of international trade. In international trade, the importation and exportation of goods are limited by import quotas and mandates from the customs department.



Crime Statistics

Crime is any illegal activity that is prohibited by the law. A crime is often called an 'offence'. Thus a crime is any act or omission that violates a law which results in a punishment. Punishments can range from the payment of a fine to incarceration in jail. The level of the offense or crime will usually be set in proportion to the severity of the crime. Robbing someone at gun point is a severe crime that can result in a lengthy prison sentence while driving while using a cell phone is a less severe crime that may result in the issuing of a ticket or a fee.

Crime prevention is the attempt to reduce and deter crime and criminals. It is applied specifically to efforts made by governments and police to reduce crime, enforce the law, and maintain criminal justice.

The impact of crime on the people affected by it can be profound. Victims may suffer from physical, mental, emotional and financial harm, from which some may never recover. Injuries may be threatened or inflicted upon victims, witnesses or their families, and threats may even be made against lives. The cooperation of victims and witnesses is crucial to achieving successful prosecutions of criminal offenders and dismantling organized criminal groups. Victims who receive appropriate and adequate care and support are more likely to cooperate with the criminal justice system in bringing perpetrators of crime to justice


